

THE CLUB AT ADMIRALS COVE

November 1, 2017 – October 31, 2018

Exempt Property Affiliate - Affiliate is entitled to use all of the swimming, fitness and social facilities of the Club and restricted use of the golf and tennis facilities of the Club. There will be one (1) day sign-up privilege to reserve golf starting times and tennis court times. Use of each of the golf and tennis facilities will be restricted to one (1) time per month during the period from November 1 thru April 30 and two (2) times per month during the period from May 1 through October 31.

Legacy Affiliate - A Legacy Affiliate shall have use of all of the dining, swimming, fitness, spa, salon, card rooms, tennis and social facilities of the Club. A Legacy Affiliate shall have no right to use any golf facilities, except as a guest of an Equity Club Member pursuant to and as limited to once per week. Golf Guest fees and cart fees apply.

A Legacy Affiliate shall have half the number of days as Club Members to make advance registration for holiday and limited seating Club events.

Legacy Golf Affiliate - A Legacy Golf Affiliate shall have use of all of the dining, swimming, fitness, spa, salon, card rooms, tennis and social facilities of the Club. A Legacy Golf Affiliate will have a three (3) day advance sign-up privilege to reserve golf starting times and tennis court reservations – no fee for golf or tennis, only \$32 cart fees apply (per play) or \$1300 Trail Fee (annually).

A Legacy Affiliate shall have half the number of days as Club Members to make advance registration for holiday and limited seating Club events.

Marina Membership - A Marina Membership will entitle a member to use all tennis, swimming, fitness and social facilities of the Club and entitles the member to restricted use of the golf facilities.. Sports Marina Members are allowed to use the golf facilities to ten (10) times per month after 11:00 a.m. (with a maximum of two (2) times on the East Course from November 1st to April 30th and unlimited use during the period from May 1st through October 31st. Marina Sports Members will not be required to pay a Green Fee, only \$32 Cart Fee.
