GOLF

Full Equity Member Golf Privileges

Full Equity Membership includes golf privileges without restriction. Full Equity Members do not pay greens fees. Mandatory Annual Cart Fee includes carts for Full Equity Members and their guests.

Advance Tee Times - Full Equity Members may request tee times up to 14 days in advance utilizing the Tee Time Reservation System. Requests will be processed, and tee times assigned 5 days in advance.

Standard Equity Member (Standard & Social Dues Members) Golf Privileges

Standard Equity Members can use the course/practice facility within the following guidelines:

- The definition of "golf usage" shall constitute one tee time for up to four players (9 or 18 holes) including use of the Driving Range or Toptracer, 60 minutes prior to that tee time on the same day.
- Standard Equity Members may use the Driving Range, or Toptracer, without play on the course, but it will count as a golf usage.
- The number of golf usages is per Membership, not per person.
- Standard Equity House Guest's usage counts towards the Host Membership's usage.
- Standard Equity Members and their families are entitled to participate in unlimited golf lessons and golf clinics, and may use the practice facility, including Toptracer, up to 60 minutes before and after a golf lesson (minimum 30-minute golf lesson required); no usage applies. Clinics, group lessons, lesson packages and junior programs are available.
- Tournament participation and league play is restricted to Full Equity Members only.

Advance Tee Times - Standard Equity Members may request tee times one day in advance through the Golf Pro Shop.

Practice Facility Access, including Toptracer, for Standard Equity Members

- Allowed up to 60 minutes before tee time. No access after play. *Included in play usage.*
- Allowed up to 60 minutes before and after a golf lesson. Minimum 30-minute golf lesson required. *Does not count towards usage.*
- Certified Juniors (ages 12-17) approved by the Director of Golf may access the golf course and practice facilities daily after 2:00 p.m. without it being counted as a usage. Greens fees and cart fees are one half the prevailing rate. Certified Juniors may bring guests who are under the age of 18. These guests must have a USGA handicap of 36 or lower. Guests will pay greens fees and cart fees at one half the prevailing rate and count as a full usage.

Guest Golf Privileges

- The same guest is limited to 4 rounds In-Season and 4 rounds during the Off-Season, regardless of the host Equity Member.
- Guests are entitled to participate in unlimited golf lessons and golf clinics, and may use the practice facility, including Toptracer, up to 60 minutes before and after a golf lesson (minimum 30-minute golf lesson required); no usage applies. Clinics, group lessons, lesson packages and junior programs are available.
- Guests must be accompanied by the host Member when playing golf, unless a House Guest pass has been purchased.

Guests of Full Equity Members

- Participation in tournaments or events by Full Equity day guests or Full Equity House Guests does not count towards guest usage.
- Full Equity House Guests, with HG pass, pay the same greens fees as day guests.
- Full Equity House Guests, with HG pass, who present valid government issued identification verifying they live at least 60 miles away from Woodfield will not have their usage count towards guest usage.
- Full Equity House Guests, with HG pass, who live within 60 miles of Woodfield will have their usage count towards guest usage.
- Full Equity House Guests, with HG pass, may request tee times up to 2 days in advance through the Golf Pro Shop.

Guests of Standard Equity Members

- Standard Equity Members may bring up to 3 guests per golf usage.
- Guests of Standard Equity Members pay the same greens and cart fees as Standard Equity Members.
- Guests of Golf Upgrade Waitlist Members pay the same greens and cart fees as Standard Equity Members.
- Standard Equity House Guest's usage counts towards the Host Membership's usage.
- Standard Equity House Guests may request tee times one day in advance through the Golf Pro Shop.

Golf Access for Members on the Golf Upgrade Waitlist

Standard Equity Members on the Golf Upgrade Waitlist can use the course/practice facility within the following guidelines:

In-Season (October 15-May 15)

- Golf Upgrade Waitlist Members will be permitted 4 golf usages.
- Golf Upgrade Waitlist Members will be permitted to split each golf usage into 2, 9-hole usages.
 - For example, a Member could split their 4 golf usages into 8, 9-hole usages. Any combination of 9-hole usages and 18-hole usages will be permitted so long as the usage amount does not exceed the allotted 72 holes.
- Both 9-hole and 18-hole usages include use of the Driving Range and Toptracer 60 minutes prior to the tee time on the same day.
- Use of the Driving Range and Toptracer without play on the course will count as an 18-hole golf usage.
- Usages are per Membership, not per person.

Summer Access (June 1-September 30)

- Once summer golf access begins, Golf Upgrade Waitlist Members may request a tee time 4 days in advance by emailing their request to golfpros@woodfield.org after 3:00 p.m.
- Golf Upgrade Waitlist Members are not subject to any time restrictions.
- Golf Upgrade Waitlist Members may participate in Club sponsored golf tournaments that take place between June 1-September 30. Full Equity Members will have a priority registration window.
- Team/League play is not permitted.

TENNIS

Full and Standard (Sport) Membership includes tennis privileges without restriction, including use of SwingVision technology.

Guests of Full and Standard (Sport) Members

- Court reservations must include two or more players.
- Day Guests and House Guests who live within 60 miles of Woodfield may use the tennis courts no more than 8 times In-Season and 12 times Off-Season, as listed below, regardless of the host Equity Member.
- Full and Standard (Sport) House Guests, with HG pass, who present valid government issued identification verifying they live at least 60 miles away from Woodfield, will not have their usage count towards guest usage. Additionally, those holding a distant HG pass do not pay the additional guest fee from 12:00-4:00 p.m. If play begins before or extends after this window, guest fees will be applied.
- Guests are entitled to participate in unlimited tennis lessons and tennis clinics. No usage applies.
- June, July & August (Complimentary Guest Days)
 - Summer guest fees for non-residents who are guests of Full or Standard (Sport) Members are waived after 10:30 a.m. during these three months. *Counts towards guest usage.*

Social Membership Tennis Privileges

- Social Members are permitted 6 court usages In-Season (October 15-May 15) and 12 court usages during the Off-Season (May 16-October 14), Social Members may play during prime time as long as there are two Full and/or Standard (Sport) Members playing with the Social Member.
- Social Members may bring guests after 12:00 p.m. or prior to 12:00 p.m. on a walk-on basis only based on court availability.
- Social Members may reserve courts after 12:00 p.m. 2 days in advance through the Tennis Pro Shop.
- No usage shall commence before 12:00 p.m. unless as stated above.
- Social Members may not participate in tennis special events or league play.
- Social Members are entitled to participate in unlimited tennis lessons and tennis clinics. No usage applies.
- Use of the ball machine constitutes as a court usage for Social Members and guests.
- The number of court usages is per Membership, not per person.
- Social House Guest's usage counts towards the Host Membership's usage.

PICKLEBALL

Full, Standard (Sport), and Social Membership includes pickleball privileges without restriction, including use of SwingVision Technology. For pickleball private and semi-private lessons, see Lesson Fee Schedule above.

Guests

- Court reservations must include two or more players.
- Day Guests and House Guests who live within 60 miles of Woodfield may use the pickleball courts no more than 8 times In-Season and 12 times Off-Season, as listed below, regardless of the host Member.
- Full, Standard (Sport), and Social House Guests, with HG pass, who present valid government issued identification verifying they live at least 60 miles away from Woodfield, will not have their usage count towards guest usage. Additionally, those holding a distant HG pass do not pay the additional guest fee from 12:30-4:00 p.m. If play begins before or extends after this window, guest fees will be applied.
- Guests are entitled to participate in unlimited pickleball lessons and pickleball clinics. No usage applies.
- June, July & August (Complimentary Guest Days)
 - Summer guest fees for non-residents who are guests of Members are waived after 11:00 a.m. during these three months. *Counts towards guest usage.*

Advance Court Times - Members may go online at www.woodfield.org or call the Pickleball Desk for morning court times up to 30 days in advance. For morning reservations within the next five days, call the Pickleball Desk. Afternoon court times may be reserved up to five days in advance by calling the Pickleball Desk.

FITNESS

Full and Standard Equity Membership includes use of the Fitness Center without restriction.

- All Juniors ages 9-15 must complete a Junior Certification Program to use the Fitness Center
- Children ages 9-11 years may use the Fitness facilities after 11:00 a.m. every day and must be supervised by an adult Member. For this age group, privileges are extended to normal guest hours during the summer (June 1- August 31).
- Children under 12 years of age may train with a personal trainer during normal hours of operation.
- Children ages 12-15 years may use the Fitness facilities during normal hours of operation.
- Children ages 12 and up may attend most fitness classes. Members must be 16 years or older to attend a Pilates Reformer Class and 12 years or older for Pilates Private Instruction.

Guests

- Guests using the Fitness Center may do so within the following guidelines. Day guests must be accompanied by the Member at all times. Guest hours are outlined below.

LEGACY MEMBER ACCESS

- Legacy Members have the same access as Equity Members for all Club social events, Club-wide children's events and camps, and dining reservations.
- Legacy Members have unrestricted access to Fitness.
- Full & Standard Legacy Members may participate in select social Tennis and Pickleball adult events throughout the year. Equity Members will have a priority registration window.
- Social Legacy Members may participate in select social Pickleball adult events throughout the year. Equity Members will have a priority registration window.
- Full & Standard Legacy Members are restricted to guest times for Golf & Tennis.
- Legacy Members may not participate in any Golf, Tennis or Pickleball tournaments or leagues.*
- The Equity Member will be responsible for all charges incurred by the Legacy Single or Family Member and his/her guests.
- **Full Legacy Members may participate in Club sponsored golf tournaments that take place between June 1-September 30. Full Equity Members will have a priority registration window.*

HOUSE GUEST PASSES

House Guest passes may be requested for the time periods listed below:

- 1-4 days - \$50 per person
- Up to one week - \$80 per person
- Up to two weeks - \$110 per person
- Up to four weeks - \$160 per person
- Four-week passes are for out-of-state residents only.
- House Guests must have at least 30 days between visits.
 - This 30-day waiting period is waived for immediate family members during the holiday season of November 1-February 15. *Immediate family members are defined as one generation up and two generations down.*

House Guest privileges are extended in accordance with the membership category of the sponsoring Member, either: Full, Standard (Sport) or Social. All guest charges are charged to the Member's account. A House Guest Pass allows guests access to the following:

- Dining at all Club restaurants.
- Complimentary use of the Fitness Center after 11:00 a.m. In-Season and after 10:00 a.m. Off-Season.
- Spa and salon appointments. House Guests are welcome to make advance appointments or walk-in.
- Golf lessons, tennis lessons, pickleball lessons, personal training sessions and babysitting.
- House Guests are welcome to make purchases at the Golf and Tennis Pro Shops and Spa & Salon Boutique.
- House Guests are restricted to guest times in all areas and subject to fees for golf, tennis and pickleball.
- House Guests of Full or Standard (Sport) Members may play tennis after 12:00 p.m. on a walk-on basis only (no advance sign up).
- House Guests of Full Members are entitled to a two-day advance tee time. Guests of Standard (Sport) & Social Members may request tee times one-day in advance through the Golf Pro Shop.
- Guests are required to check in at all outlets (e.g., Fitness Desk, Tennis Pro Shop, Pickleball Desk, Golf Pro Shop, hostess, Pool Desk, Spa & Salon, Children's Clubhouse).
- House Guests may not use the Card Rooms without the host Member.
- Guests may not have guests, with the exception of dining and the pool (see below).
 - House Guests with a valid House Guest Pass are permitted to bring up to two guests with them to the Pool Complex. Purchase of a Pool Day Pass is required (see Miscellaneous Fees section).
- Passes may only be used by the person listed and must be carried at all times and presented when asked when using the facilities.
- All charges incurred by the House Guest will be posted to the host Member's account.

Membership includes the Member, the Member's spouse or single designee and unmarried children under the age of 26 who live at home or attend school on a full-time basis.

- Membership fees are non-refundable.
- Please refer to the Club's By-Laws and Rules & Regulations for further information. The Board retains the flexibility to reconsider these or any other programs.
- Certain fees and charges are subject to Florida sales tax.
